This was provided for emergency use and that purpose only. Veronica Petersen used such phone for personal use, creating a bill over \$300 USD never paid and refused payment, prior termination of service to the line. JAMES ALLEN did not report the refusal to return the handset as theft of a property, which at that time required a formal criminal complaint prior to processing by the carrier, because it would implicate Veronica Petersen in a crime and impair her ability to care for his child and sibling who had lived in his home.
